## Welcome to our First Annual Old Town Goleta Christmas Parade !

In order for the evening to run smoothly, we need to address the following:

1. All participants 18 years and older must sign liability release waiver (Copy of Waiver is included in packet, print as many as you need). Each person must sign his own waiver form. This is a requirement of the City Of Goleta. Anyone under the age of 18 years must have the release signed by parent or guardian. ***NO EXCEPTIONS! NO SIGNED WAIVER, NO PARADE PARTICIPATION.*** Please return signed waivers for all of your participants together to the Goleta Community Center business office ( 5679 Hollister Ave.) by 6pm on Thursday, December 8, 2016.
2. As you have received this by e-mail, we will follow up with a courtesy call on Tuesday, December 6, or Wednesday, December 7, to answer any questions you may have.
3. We will also have an informational meeting at the Community Center ( Room 6 )at 5:30 pm on Thursday, December 8, in case you still have questions or wish to turn in your waivers.
4. **Float, truck, and group recognition.** You are encouraged to light up your entry and provide banners or signage to identify your group during Parade.
5. **Parade float, vehicle and participant Entry.** The attached directional map "A" shows you where to enter your group or vehicle for check-in and drop off. Proceed south on Fairview Avenue, towards Airport, and enter into the "Yardi" parking lot. Follow the signs and traffic monitors.
6. **Check-In.** Check-in will be open at 4:30 and as the streets are closed at 5pm, we will begin staging participants on Orange Street and the first block of Hollister. Each entry needs a designated person to check in at our check-in station as you arrive.
7. You will be directed to the staging area and your specific "waiting spot" by our volunteers. All of our volunteers will be wearing "orange reflective vests" for identification. Please ask them for help if needed.
8. Restrooms for the staging area will be at the corner of Hollister Ave. and Orange St.
9. As you can see on the map, spectator parking is available in the nearby lots.
10. The Parade will begin at 6:30 pm and proceeds down Hollister Avenue where it ends at the Community Center. If you wish, after dropping off parade participants, you can drive down to the Community Center and park in the rear parking lot. The lot will close to vehicle entry at 6pm. Entry into lot is from Kinman Avenue ( see map B )

**11. End of Parade Disbursement.** You will have one of three options and we will want to know which option you select when we give you our informational phone call on Tuesday.

**Option One** At the end of the parade we will have busses available to take participants back to the original parade check-in area. You must sign up for bus ride in advance. Please contact Jo if you will be needing transportation back to Yardi parking lot.

**Option Two** At end of parade you can continue straight ahead and exit east on Hollister or turn onto Kellogg Ave.

**Option Three** You can enter into the Community Center driveway and proceed into the parking lot behind the Center. Follow the signs to the exit by the Boys and Girls Club or park in the lot and join the festivities at the Community Center.

12. Please review the rules for participation before the Parade. Remember, there is absolutely NO throwing of any candy or other items from your Parade entry.

13. It will be cold, so make sure you dress warmly. Wear comfortable shoes if you are walking.

14. Be safe, Be safe, and Be safe!

15. Santa will be at the Community Center after the end of the Parade. Children can write letters and meet with Santa at the Gazebo. There will be music, food and some entertaining activities inside and out and everyone is invited to join.

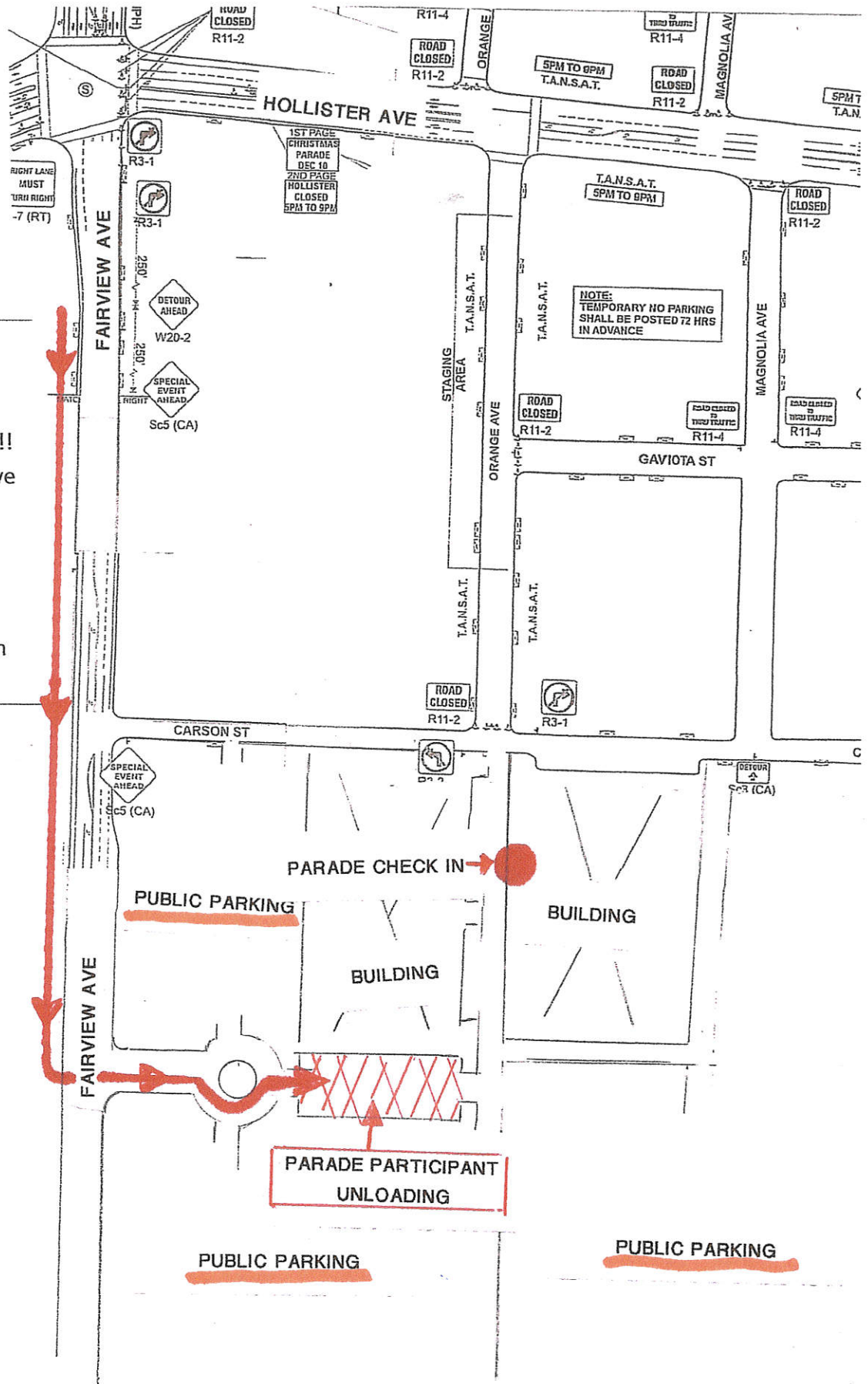

Entry is posted for left turn into parking area.

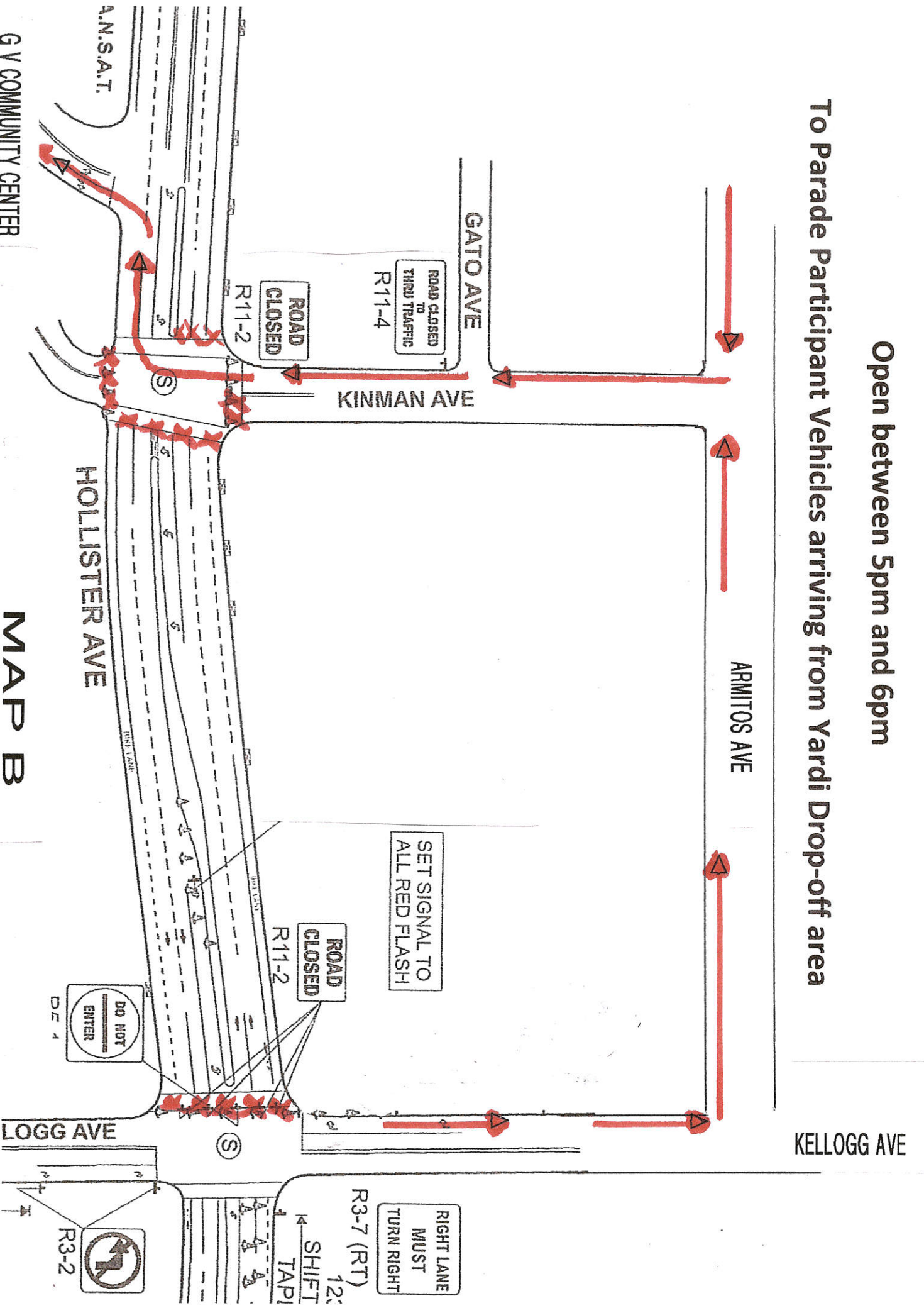


**MAP A**
